Rules and Regulations:

- 1. Exhibitors wishing to participate please to email product pictures, prices and profile to us at hhindia.helpinghands@gmail.com
- 2. Registration will be confirmed after the screening process and making of full payment.
- 3. Once approved, the completed form, pan card copy, GST details with the payment are to be submitted.
- 4. Cheques in the name of "M.G.Global Pvt.Ltd.". All RTGS payments need an email proof of payment for receipts.
- 5. As per statutory requirement, taxes will be charged as applicable.
- 6. Allocation of stalls is solely at the discretion of the HHF Exhibition Committee members. No floor plans will be provided to participants.
- 7. Payment for accessories to be made directly by participants to the approved vendor on the morning of the event. Accessory forms will be sent on completion of payment.
- 8. Participants may display only those products in their stalls that have been approved during the screening process. No "sale" or "discount" signs are permitted.
- 9. No cancellations or refunds will be entertained in the event of a participant cancelling a stall, for whatever reason, after confirmation of booking and making full payment.
- 10. Stalls, once registered, are non-transferable. No sharing is allowed.
- 11. Any damage/loss of the rented furniture, i.e. stands, hangers, hooks, rods, tables, etc., will be charged based on the actual cost of the damaged/lost item.
- 12. No requests for extra furniture / accessories will be entertained on event day.
- 13. Should the event be cancelled because Force Majeure, Act of God, riots / strikes / fire / terrorism or any other man-made or natural disaster: if possible, the event will be held on another date. If this is not possible for reasons beyond the control of the organizers, there will be no refund.
- 14. M.G. Global will promote the event with the required publicity. However, we do not guarantee footfall and sales.
- 15. Participants must be present at the stall themselves.
- 16. Stalls will be handed over to participants at 7 a.m. on the day of the event. The fundraiser will close at 8.00 p.m. sharp. Loaders will be available at a nominal cost.
- 17. Participants should ensure stalls are ready & packing material is cleared by 9.30 a.m.
- 18. Participants are responsible for goods displayed in their stalls and HHF is not liable for any loss or theft.
- 19. All product displays should be within the stall boundaries and no items should encroach on the passageways. **This is Non-Negotiable and a safety hazard**.
- 20. Stall holders will be provided lunch (2 persons per stall). Table spaces will get 1 coupon.
- 21. We have a One Month non-participation clause in any other show prior to ours in Mumbai, and there will be no refund.
- 22. We sell breakfast and tea/coffee coupons at the venue at a nominal charge.
- 23. Table spaces will be provided with one table and 2 chairs. Food product vendors (1 mtr table) can hire one extra accessory only at a cost from the contractor.
- 24. Foyer tables (6 feet) cannot hire any accessories at all due to space restrictions. No standees will be permitted. Strictly one table only for low cost items.
- 25. Stalls will be provided with 1 table, 2 chairs and 2 spotlights.
- 26. Stall holders are requested to keep their Vat /Pan/ GST documents and/or other necessary government documents available always.
- 27. No receipts will be issued without pan card submission.
